## making a will

- You can never be certain what will happen in the future. By making a Will, you can ensure that your money and possessions will be shared out in accordance with your wishes, thereby providing security for your family and friends.
- When it comes to making a Will, your loved ones and family should come first in your thoughts. But many people also like to remember a special charity that is close to their hearts, and Francis House is one such charity.
- Perhaps you would be kind enough to remember the families who come to Francis House in your legacy.







Children who come to Francis House have to be under 16 years of age when they join our roll and be diagnosed as having a life-limiting or life-threatening condition. Each family is treated individually and our aim is to care for the child in exactly the way that their family would care for them at home.

Whilst hospitals must focus on curing those who are ill, the hospice focus is on the care of those for whom a cure is unlikely. All of our support is centred on comfort, quality of care and death with dignity.

including Francis House in your will

By including a Legacy to Francis House your gift will help others make their own precious memories.

The expert care and support that we provide for our families is very costly. Our annual running costs exceed £4 million. We receive little support from the government and we rely heavily upon the support of people like you.

Almost £1 million of the £4 million that we need to fund our work each year comes from bequests.

Francis House is administered by the Francis House Family Trust, a Registered Charity.





## what to do next

- Making a Will isn't difficult or expensive but we would always recommend that you use a solicitor to prepare the Will for you. Only a properly drawn up Will is recognised by law, even if you have written down your wishes.
- Your chosen solicitor will provide you with independent professional advice.
- You can prepare in advance a list of the estimated assets, outstanding debts, beneficiaries and registered charities that you would like included in your Will. Decide who you would like to be your executors (the person or people you would trust to ensure that your wishes are carried out when you die).

- Decide whom you would wish to benefit (please remember to include a gift to Francis House).
- **2.** Contact your chosen solicitor for an appointment.

If you do not have your own solicitor please contact our fundraising team on **0161 443 2200** and they will be able to provide you with the details of a number of solicitors local to you who specialise in Will writing. # there are three different types of gifts that are contained in a will

- A residuary gift a gift of the remainder or part of the remainder of your estate once all other gifts have been paid. This is a popular way to remember a charity because it is expressed as a fraction of your estate rather than a cash sum and therefore retains its value over time.
- A pecuniary gift this is a gift of a fixed amount of money. However, unless you review the amount regularly, the value of this legacy may reduce through the effects of inflation.
- A specific gift of personal possessions such as antiques, furniture, jewellery, land or buildings.
   Gifts can raise much needed funds (dependent on their market value at the time of sale).

Please consider including a gift to Francis House in your Will to help us support the many children, young adults and families that rely on our services now and in the future.


